A motion made by Director Foley and seconded by Director Harper, to declare a state of emergency and schedule a closed session to discuss the potential work stoppage of the Maintenance workforce represented by Teamsters Local 952. The motion failed 11-5.



A discussion ensued between Board members regarding the following:

- Concerns regarding correspondence sent to a few of the Directors from Teamsters Local 952 and were not provided to all Board Members.
- Scheduling a closed session for December 5, 2022.
- There may be a work stoppage if the November 30 deadline passes with no resolution between the parties.

James Donich, General Counsel, stated that OCTA is not currently undergoing a work stoppage. There is an assumption of a work stoppage.
