7. Orange County Transportation Authority Investment and Debt Programs Report - June 2018

Overview

The Orange County Transportation Authority has a comprehensive investment and debt program to fund its immediate and long-term cash flow demands. Each month, the Treasurer submits a report detailing investment allocation, performance, compliance, outstanding debt balances, and credit ratings for the Orange County Transportation Authority's debt program. This report is for the month ending June 30, 2018. The report has been reviewed and is consistent with the investment practices contained in the Investment Policy. During the month of June 2018, Moody's downgraded the rating for Union Pacific Corp. to Baa1 from A3 in the Logan Circle portfolio, which fell below the minimum credit requirement. After review by the Treasurer, the security was liquidated from the portfolio.

8. Fourth Quarter Fiscal Year 2017-18 Procurement Status Report Virginia Abadessa/Andrew Oftelie

Overview

The fourth quarter procurement status report summarizes the procurement activities for information purposes to the Orange County Transportation Authority Board of Directors. This report focuses on procurement activities from April 1 through June 30, 2018, that were approved by the Board of Directors during this period. The fourth quarter procurement status report also projects future procurement activities for the first quarter as identified in the fiscal year 2018-19 budget.

9. OC Flex Update and Proposed Fare Sam Kaur/Andrew Oftelie

Overview

Orange County Transportation Authority plans to implement a pilot micro-transit service branded as OC Flex in two areas within Orange County. This report provides an implementation update, as well as information on the proposed fares for the service.

Recommendation

Approve the OC Flex fare of \$5.00 for onboard cash paying customers or \$4.50 for customers that use prepaid fare media.

10. Fiscal Year 2018-19 Budget Amendment Victor Velasquez/Andrew Oftelie

Overview

The budget authority for the purchase of the OC Streetcar vehicles was included in last year's budget. However, negotiations on this contract were finalized shortly after the start of the new fiscal year. Staff proposes to amend the Orange County Transportation Authority Fiscal Year 2018-19 Budget in order to properly align the actuals and budget authority in the same fiscal year.

Recommendation

Amend the Orange County Transportation Authority's Fiscal Year 2018-19 Budget by \$51,527,520, to accommodate Agreement No. C-6-1445, for the purchase of eight streetcar vehicles, spare parts, and special tooling for the OC Streetcar project.

11. New York Meetings Update - June 2018 Jennifer Matano/Andrew Oftelie

Overview

Since the early 1990s, the Orange County Transportation Authority has maintained an active investor relations program. 12. Interstate 405 Improvement Project: Project Management Contracts, Internal Audit Report No. 18-505 Serena Ng/Janet Sutter

Overview

The Internal Audit Department has completed an audit of oversight controls and contract compliance related to the project management contracts for the Interstate 405 Improvement Project. Based on the audit, billed labor rates complied with the contracts; however, there is excessive use of labor classifications and a lack of controls over labor rate increases for personnel billed within these classifications. There were also concerns related to oversight of consultant staff time.



12. (Continued)

Consultants were procured in compliance with policy and contract amendments were approved as required; however, amendments have been back-dated outside the limits outlined in procedures. Finally, while cost estimates are submitted to support amendments to increase the contract maximum obligation, management does not validate all of the listed labor rates to payroll registers.

Recommendation

Direct staff to implement four recommendations provided in Interstate 405 Improvement Project: Project Management Contracts, Internal Audit Report No. 18-505.
