## 3. Agreement for Datrium Data Center Equipment

# 6. Fiscal Year 2017-18 Comprehensive Annual Financial Report and 91 Express Lanes Fund Financial Statements

Sean Murdock, Director of Finance and Administration, provided opening comments and a brief update on this item, as well as introduced Roger Alfaro, Partner, Vavrinek, Trine, Day and Company, LLP.

Mr. Alfaro reported on the following:

- Process focuses heavily on the Orange County Transportation Authority's (OCTA) internal controls.
- No deficiencies were identified in the internal controls that would be considered material weaknesses.
- No difficulties were encountered during the audit.

Director Steel inquired on the 2018-19 forecast for external grants and what would happen if OCTA did not obtain the grants.

Mr. Murdock stated that OCTA is good at obtaining grants and if grants they were not obtained, the Measure M2 and bus service programs would continue.

Andrew Oftelie, Executive Director of Finance and Administration, thanked several staff for their efforts and countless hours spent to ensure the Comprehensive Annual Financial Report was delivered on-time.
