1. Approval of Minutes

2. Amendment to Cooperative Agreement with the County of Orange, Orange County Sheriff's Department

A motion was made by Director Do, seconded by Director Bartlett, declared passed those and by present, to authorize Chief Executive Officer to negotiate and execute Amendment No. 3 to Cooperative Agreement No. C-0-2330 between the Orange County Transportation Authority and County of Orange, Orange County Sheriff's \$11,674,866, Department, in the amount of Transit Police Services, effective July 1, 2022, through June 30, 2023. This will increase the maximum obligation of the agreement to a total contract value of \$33,414,261.

405 Improvement Project

- OCTA had to close a portion of the 405 in both directions overnight in Costa Mesa over the weekend as part of the Interstate 405 (I-405) Improvement Project.
- This closure enabled construction crews to make significant progress and pour concrete for the new connector between the State Route 73 (SR-73) and the I-405 Express Lanes.
- The freeway was reopened to traffic in both directions at approximately 2:00 p.m. yesterday.
- The project is now more than 75 percent complete.
