2. Approval of Minutes

A motion was made by Member Rush, seconded by Member Hanna, and following a roll call vote, declared passed 6-0, by those present, to approve the minutes of the March 2, 2018 meeting.

Committee Member Murray abstained as he was not in attendance at the March 2, 2018 meeting.

3. Joint 91 Express Lanes Monthly Status Reports

Discussion Items

5. State Route 91 Corridor Operation Improvements in Riverside County

Michael Blomquist, Toll Program Director, Riverside County Transportation Commission (RCTC), provided opening remarks on RCTC's authorization to implement several operation improvements along the SR-91 corridor and provided a PowerPoint presentation as follows:.

- Work Performed Since Opening;
- Express Lanes Entrance at Interstate 15 Northbound Recommendation (Option 1);
- General Purpose Lanes Westbound Near the County Line Recommendation (Option 3);
- General Purpose Lanes Westbound Near the County Line Recommendation (Option 4); and
- Policy Considerations and Next Steps.

A discussion ensued regarding:

- Staff is coordinating trial efforts to turn off the on-ramp meter westbound at Green River during the next several months.
- Egress weaving has a stopping point after Green River, and Option 3 would provide a benefit and remove the more dedicated egress/ingress points making this more of a continuous weave area/zone;

Following the discussion, no action was taken on this information item.

6. 91 Express Lanes 6C Transponder Technology Transition

Jennifer Crosson, Toll Operations Manager, RCTC, provided opening remarks on the upcoming transition to 6C transponder technology for the 91 Express Lanes, and reported that as part of this requirement, OCTA and RCTC are developing a deployment plan for the new transponders.

Ms. Crosson provided a PowerPoint presentation on this item as follows:

- 91 Express Lanes Account Plans;
- 91 Express Lanes Customers by Plan;
- Goals of the Transition;
- Transition Plan Summary; and
- Next Steps.

A discussion ensued regarding:

- The Title 21 mandate comes with no funding.
- There is a five-year deadline to complete the transition to the 6C transponder technology; however, staff is gearing to complete the transition within the next 12 months.
- Currently, a person who sells their vehicle would have to de-activate their account if a 6C sticker is on that vehicle when sold.
- Staff is investigating with the California Toll Operator Committee if 6C transporter stickers placed on a vehicle which is later sold, can be used by a new vehicle owner.
- Staff is checking on compatibility of the 6C stickers for other locations such as airports, other states, etcetera.
- Distribution roll-out to fleet customers: It is estimated that most fleet customers sit in 91 Express Lanes account base (approximately 1,800 accounts), and toll operators have been working daily with these members to assist and answer their concerns.
- Since the system works from a begin date to an end date, from a customer service perspective, staff will look into ways to "cleaning up" the 6C sticker vehicle history on the web (e.g., when sticker is used on a rental car, a car is sold, etcetera).

Following the discussion, no action was taken on this information item.

7. General Manager's Report – Orange County Transportation Authority

Kirk Avila, General Manager, OCTA, 91 Express Lanes, reported on the following items:

- Since the one-year anniversary of RCTC's opening, OCTA's segment of the 91 Express Lanes has noticed the following:
 - Total ridership has increased on the facility by approximately 14.5 percent; most noticeable on the westbound side by over 20 percent.
 - Shift in travel patterns on the westbound direction as compared to historical travel records.

7. (Continued)

- During the last reported month, approximately 51 percent travel eastbound, and westbound travel increased to approximately 49 percent.
- Earlier this year, the OCTA Board of Directors approved the ten-year lease to move the Customer Service Center from the current location to the RCTC Corporate Terrace Circle Building.
- Beginning July 1, 2018, for OCTA's segment of the 91 Express Lanes, a two percent cost of living adjustment will be applied. The two percent adjustment is annually imposed upon the toll rates that have not been increased over the past year.

8. Toll Program Director's Report – Riverside County Transportation Commission

Michael Blomquist, Toll Program Director, RCTC, reported on the following items:

- As it relates to the 6C transponder changes, as of May 10, 2018, staff
 has received a number of proposals from industry vendors and the
 proposals evaluation is almost complete. Staff plans to bring an item to the
 RCTC Board of Directors (Board) on the proposals received in late
 June 2018, and the July 2018 Board meeting for the award of the contract.
- The ten-year lease to move the Customer Service Center from the current location to the RCTC Corporate Terrace Circle Building was executed on May 31, 2018. An opening event will take place the beginning of 2019.
- RCTC will also apply a two percent cost of living adjustment to certain tolls.
- The I-15 Express Lanes Project started construction in April 2018, and overlaps with the 91 Express Lanes on the east end of the corridor. The project is scheduled to open in 2020.
- Over the last couple of months, the RCTC Board has awarded a couple of contracts for the 91 Express Lanes as follows:
 - Multi-year marketing contract for the I-15 and 91 Express Lanes.
 - Traffic and revenue update contract.

9. Committee Members' Reports

Committee Chair Spiegel reported that last week, the California Transportation Foundation (CTF) selected the State Route 91 Corridor Improvement Project as the 2017 Freeway Expressway Project of the Year. She noted that each year, the CTF selects top projects throughout California that present the Best of the Best. Committee Chair Spiegel also acknowledged the partnership established amongst the various agencies (RCTC, OCTA, City of Corona, the California Department of Transportation, and the Federal Highway Administration), and presented the award to OCTA.

Committee Vice Chairman Shaw thanked Committee Chair Spiegel for her remarks and the partnership with RCTC and the various agencies for the CTF's award.
